Thank you for visiting this website ("Site") for the North American Primate Sanctuary Alliance. Your privacy is very important to us. The North American Primate Sanctuary Alliance, a fiscally sponsored project of Community Initiatives, ("NAPSA", "we" or "our"). This privacy statement applies to the activities of NAPSA but not to our fiscal sponsor Community Initiatives nor any of their other fiscally sponsored projects.

By using this Site, you agree to the collection and use of information in accordance with this policy. This policy is effective as of the date noted above. We reserve the right to update or change our policy at any time. Your continued use of the Site after we post any modifications to this policy will constitute your acknowledgment of the modifications and your consent to abide and be bound by the modified policy.

#### **Information Collected**

Our Site does not collect information about you during your visit through cookies, web beacons, or other trackers for analytical purposes. Your IP address along with the date and time of your visit or pages viewed may be logged by the server for website security purposes.

# IP Addresses
